In this regard, we would like to inform you that, the Company has received an order from Custom, Excise and Service Tax Appellate Tribunal, Hyderabad (CESTAT) dismissing the revenue appeal filed in this matter by Service Tax Authority, Andhra Pradesh.

		The matter was heard by CESTAT. Upon hearing both the parties, the CESTAT passed an order dismissing the said revenue appeal filed by Service Tax Department, Hyderabad.
		A final order to this effect has been received by the Company on April 16, 2024.
