The Order stipulates for Tax liability amounting to Rs 2,60,83,083 and Penalty of Rs 26,08,308 aggregating to a demand of Rs 2,86,91,391. The said demand pertains to GST Audit conducted by GST Department, Delhi for the period 2019 - 2020.

The Company, after detailed review of the aforementioned Order, will decide on the appropriate action to protect its interests. The said Order has no material impact on the financials, operations or other activities of the Company.
